Critical Reading List

This critical reading list is meant to serve as an intervention to further the decolonisation of the curriculum. This entails a critical reflection on issues such as Eurocentrism, “methodological nationalism” (Bhambra, 2014), and coloniality of knowledge (Ascione, 2016), which still influence the university curriculum today. By shifting the epistemic vantage point and engaging with currents of thought and epistemologies from “the underside of modernity” (Dussel, 1998), we hope students and teachers can acquire the necessary tools to tackle the aforementioned asymmetries in knowledge production.

The list below includes literature from the anti-colonial, Black radical, and decolonial traditions. We have included both classic texts and more contemporary academic ones. The perspectives these texts bring forth are by nature interdisciplinary, and as such can be useful in numerous disciplines ranging from sociology and social psychology to political economy and history. We hope that this critical reading list can help teachers and students to engage with texts and perspectives that have ethical-political commitments rooted in the global South and in marginalised and oppressed communities across the globe.
