The role of municipalities in advancing sustainability



Municipalities Act

1 §

Municipalities shall advance the well-being of their residents and the vitality of their respective areas and organise services for their residents in a way that is financially, socially and environmentally sustainable.





Sustainability transformation as a local challenge



The crucial role of cities


- Contributing to <u>and</u> combating
- Consequences of crises are felt locally

Municipalities have

- Wide range of tasks
- Responsibility in organising services
- Strong role in creating the conditions for residents & businesses

Municipal strategies

- Each municipality shall have a municipal strategy in which the municipal council determines the long-term objectives for the municipality's activities and finances.

 Municipalities act § 37
- Strategy is an important tool in integrating sustainability into decision-making





Sustainability in municipal strategies

A. Guiding value or principle

"Our home city is an international and responsible city. We build its future in a socially, economically and ecologically sustainable way – with fairness, braveness and love." (Kotka)

B. Problem to be solved

"During this decade of action, it will be solved whether the world achieves the UN Agenda 2030 sustainable development targets, which have also been steering the preparing of Tampere city strategy." (Tampere)

C. Instrument to achieve other goals

"An attractive city brings also visitors to the city. We will develop Helsinki to be the world's most sustainable and smart tourist attraction." (Helsinki)

- C21 city strategies
- Cities over 50t inhabitants
- 55 % of Finnish population

Implications

Good news

- Sustainability is taken seriously
- Covers a wide range of municipal activities
- Best used simultaneously both as a value and concrete objectives
- Strong emphasis of sustainability provides a backbone for work.

Something to consider

- Ambiguity of the concept can be both an asset and an obstacle
- Mere rhetoric or implementable objectives?
- Discursive formulations vs. implementation
- If everything is defined as sustainable, where to focus?

Problem: Managing complexity

- Sustainability problems transcend administrative sectoral boundaries and require long-term solutions.
- Current management models are typically based on integrating sustainability perspectives into existing management practices.
